Recap of February General Meeting

A short meeting ensued after the second *Tracks Ahead* presentation at the Southern Oregon Public Television studio in Medford. Besides discussing the final preparations for the Club's trip to Klamath Falls for the Museum Train Show, the membership approved setting June 1 as the date for everyone's Club dues to be payable. In addition, the membership approved Club expenditure on custom designed Club cars from LBF and the purchase of two handheld DCC controllers for guests. These units are easier to use, and will give the club a total of four guest units.

March Board Meeting Recap

The RVMR Club Board met on March 9. Ray Kornell was accepted as a full member (previously an associate member). The library continues to be overhauled as Jim Dougall sorts out the older, nonvaluable magazines, fills out issues to make complete sets, and logs in the various books that the Club has recently been given. The Club is ready to go for the trip to Klamath Falls, though there may be a hitch in who will be driving the truck. The board approved the purchase of additional decoders for the Burlington F3 units donated to the Club a few years ago by John Sipple of Model RR News. Preparations are under way for sorting through the Clubhouse for items to be taken to the Eugene Swap meet in April. The Club donated some of the excess code 100 track to Ken Dencer, who has been very supportive of Club activities in Klamath Falls. We will need a nominating committee for Board elections in May. The committee's role, according to Club bylaws, is to identify a slate of candidates for the various board positions. If you would like to help on this committee, please contact Jay Mudge or Bruce McGarvey. The late Marvin Curtis's module needs to be moved from its current storefront location in downtown Medford. The Board feels the module can have a home somewhere in the Clubhouse when needed. Bruce sent the other clubs at the RR Park a letter that he will not be responsible for the media releases this year. It has been custom that someone from the Park handle the public relations releases at the start of the public run season (which begins the second Sunday in April). Bruce believes some else needs to step up and fulfill that role.

Club to Raise Roof for Layout Addition

Dave Spakousky and Larry Tuttle, both finding themselves suddenly inspired, joined their talents to redesign both the Club's upper line of track and add yet another loop for the Pacific and Eastern to better reflect the track's journey through the high Cascades. Inspired by John Allen's genius of monumental floor to ceiling scenery, the designer twins have rerouted the upper loop in a spectacular climb up and over the Cascades. In their

sudden "out of the box" thinking, Dave and Larry ignored the present limitation of the Club's ceiling/roof, and designed our new layout onto what will become the second story of the Club building. The second story design has a killer view area of the entire railroad park with room for a deck and snack area. (Treasurer Bruce McGarvey has already developed a cash flow worksheet which indicates very positive revenues that will result.)

With Larry's construction background and connections, he was able to get a prompt estimate for the addition. With a construction offer that is too good to be true, acting Chairman Jay Mudge called an emergency board meeting to immediately act on the proposal. He was heard to say that this is no time to go by the books (Club Charter and bylaws, that is) when such an opportunity is at hand. The board was immediately infatuated with the proposal and voted 4-0 in favor, especially sold by the second story deck snack bar and gift shop. Construction is to begin immediately, next month, in April. Needless to say Dave and Larry were very pleased that their effort would be coming to fruition so fast. Dave was heard to say as he left the board meeting, "Only an April Fool can really appreciate that new club addition!"

Customized Club Cars Ordered

LBF, a southern Oregon manufacturer of railroad products, has been contracted to provide the Club a set of special run cars. The Club is purchasing 240 cars, 120 of which will be three colors with unique numbers such that the Club can purchase 120 cars and no two cars will have the same number. The remaining 120 cars will be numbered with some duplication. The car to be manufactured is the 50 foot double door FMC boxcar in depot olive, Reading green, and signal red. The cars will be adorned with the "Mount Pit Route" logo and insignia, and Pacific&Eastern roadname. The cost will be approximately \$12-13 per car, which is undetermined until the final production costs come in.

Eagle Valley And Eastern To Rebuild

It has been known for some time that the EV&E has been looking for new passages since the sale of the original line several years ago. After nearly 10 years, it was announced this week that the EV&E will be rebuilding. It has acquired new trackage rights with major landowners and has already begun clearing the land for the new line. It is not clear at this time when track will be laid, but sources has it that it will be some time this spring. As of this writing, track plans were being drawn but not yet settled as to where exactly the track will be laid. The contractor for the track plans, a Dave Spakousky, would not comment. He did say however that he was confident that the plans would meet the satisfaction of the company. He has a very high confidence that there will be little change in the plans once submitted to the owner, Don Terrell, as "We have

worked together before on other projects and have had no major problems." One of the major reasons for the slow takeoff of this project is due to trying to negotiate contracts with businesses for rail service. But Don Terrell was confident that everything would work out to his advantage since the EV&E had a good reputation in the past. In fact, he said the only REAL hurdle would be if the CP&E was willing to interchange with the EV&E, and where the interchange would be.

How Much and When


